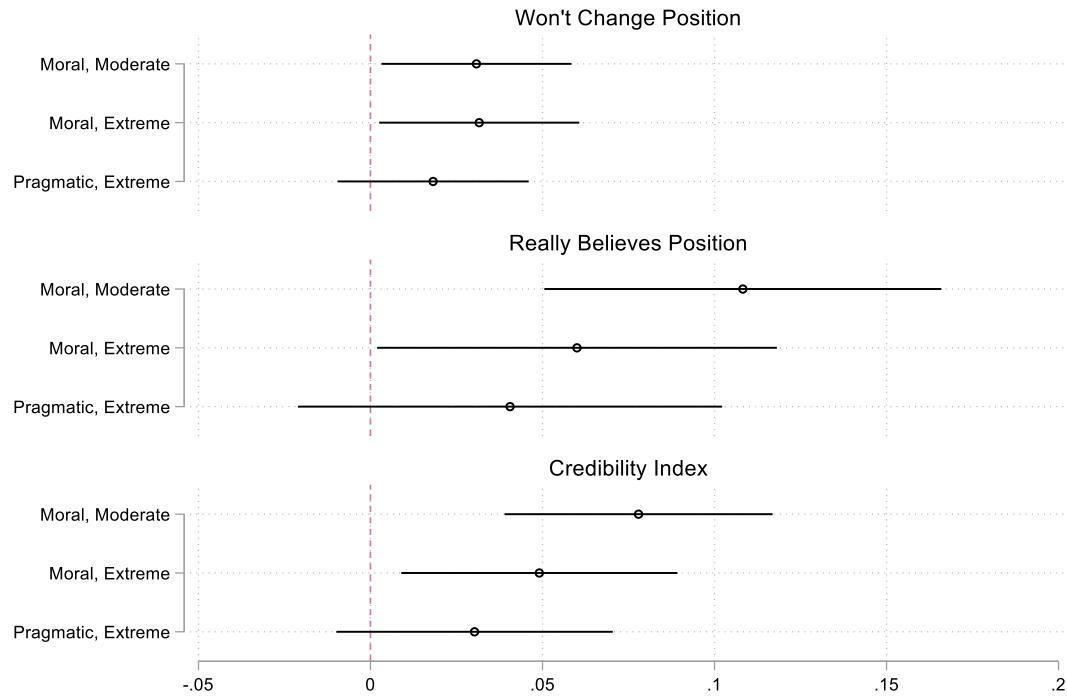

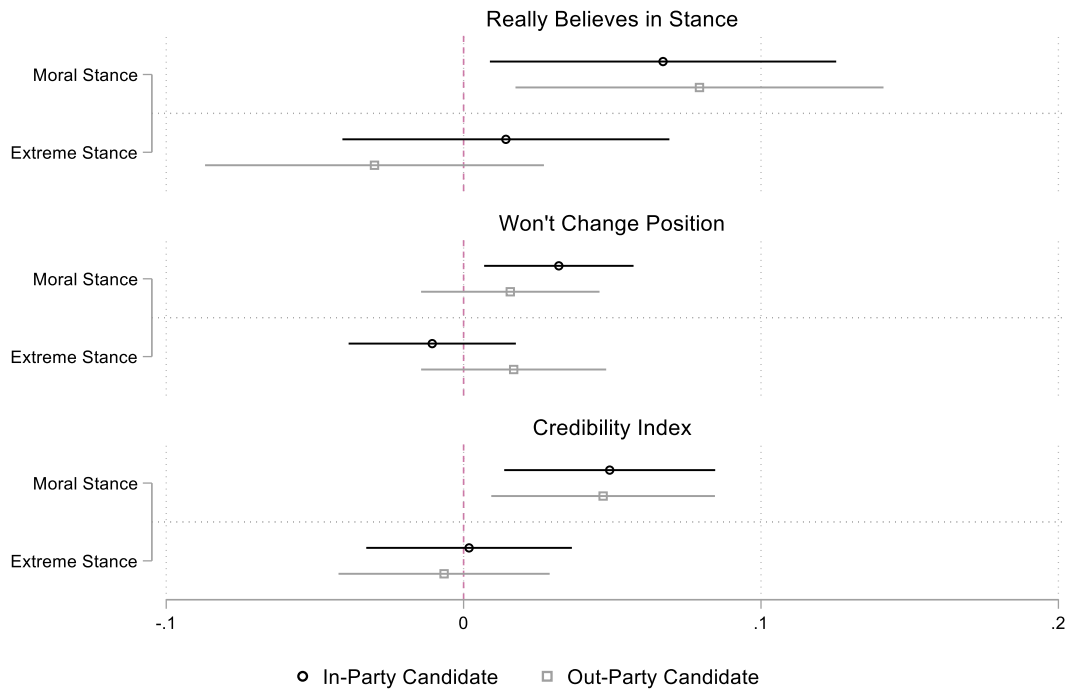
Study 1: Allowing for interactions between treatments

The figure below shows the coefficients for the moral/moderate, moral/extreme, and pragmatic/extreme conditions separately. As is clear, the effects tend to be largest for the moral/moderate condition, but these effects are not significantly different from the moral/extreme condition.



Study 1: Allowing in-party and out-party effects to differ

The figure below shows the coefficients from a model that separately estimates treatment effects for in-party candidates and out-party candidates. As is clear, we find no significant differences in treatment effects by out-party status.



Pilot Study on Measuring Perceptions of Sincerity

To improve our measure of perceptions of the sincerity of politicians' issue stances, we conducted a pilot study on 200 respondents recruited from Mechanical Turk. Our survey included questions about stances taken by two different politicians (Beto O'Rourke and Bernie Sanders) on three different issues (health care, gun control, criminal justice). Respondents were randomly assigned to evaluate two of the six stances. For each stance, respondents were shown a direct quote from one of the politicians taking a stance on one of the issues, then asked nine questions regarding their credibility on the issue. The full text of the questions is shown below:

1. Do you think <candidate> truly believes in <stance>, or is just saying what some people want to hear?
 - a. Definitely believes
 - b. Probably believes
 - c. Probably just saying what people want to hear
 - d. Definitely just saying what people want to hear

We stacked the data and conducted a factor analysis to test the structure of the data. There was a clear single factor solution. The rotated factor loadings of a single-factor model are displayed below. In selecting the final four items, we first excluded two items that did not load as well on the latent factor – a question about accepting donations and a question about achieving policy goals. The remaining seven items all loaded well on the latent factor, so we selected four items that would maintain diversity in the content of the questions and avoid pairs of items that are mostly redundant (e.g., truly believes and sincerity of the stance). Thus, we picked the top four items, shown in bold, which cover the politician’s beliefs, their motivation, and their likely behavior.

We were also interested in how perceptions of sincerity vary across candidates and across issues. To examine this variation, we estimated sincerity as a function of a candidate dummy variable (Bernie vs. Beto), an issue indicator (health, guns, criminal justice), and an interaction between the two. Additionally, we included respondent random effects and clustered standard errors on the respondent. Our results show that perceived sincerity varies both between and within candidates. Respondents viewed Bernie as significantly more sincere than Beto across all issues ($p < .01$). However, this effect was significantly larger for health care ($b = 1.06, p < .001$) than for gun control ($b = 0.48, p = .001$). Thus, while there are trait-like differences between candidates, there are also clear differences across issues as well.

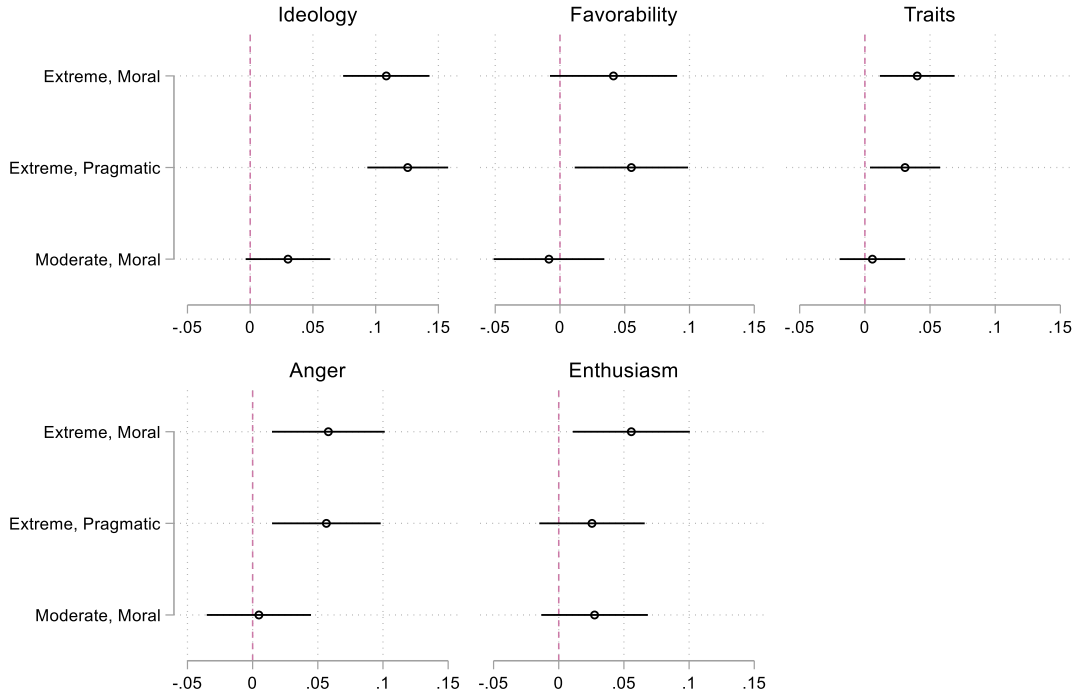

Alternative Analysis of Study 4

In the main text of the manuscript, we reported results from a model including dummy variables for the extreme and moral conditions. Here we present results from a model in which we dummy out each combination of treatments with the moderate pragmatic condition as the omitted baseline. As is clear, polarizing effects are limited to the extreme issue stances.



Ethical Statement

For all studies reported in the manuscript, we obtained voluntary and informed consent virtually prior to participating in the survey. None of our studies involved deception and all were approved by our university's institutional review board. In Study 1, we paid respondents \$0.75 if they completed the survey. The median respondent spent 5.5 minutes on the survey, for an estimated hourly rate of approximately \$8.10, which is above the US federal minimum wage of \$7.25 an hour. In Study 2, respondents were compensated by the survey vendor (NORC). In Study 3, we paid respondents \$1.00 if they completed the survey. The median respondent spent 5.4 minutes on the survey, for an estimated hourly rate of approximately \$11. In Study 4 (reported in the conclusion), respondents were compensated by the survey vendor (YouGov).
